SISTER CITY AGREEMENT

WHEREAS, the City of El Paso, in the State of Texas, of the United States of America, desires to establish a Sister City Agreement with the City of Zacatecas, in the Republic of México; and

WHEREAS, the City of El Paso, Texas, and the City of Zacatecas, México, share in the same cultural environment and seek by this Agreement to perfect increased economic interaction and cultural exchanges; and

WHEREAS, the governments of the Cities of El Paso, Texas, and Zacatecas, México, have for decades found favorable relations between the cities to be their mutual best interest; and

WHEREAS, the City of El Paso desires to promote the social, economic and cultural interests of the City of Zacatecas; and

WHEREAS, the City of Zacatecas desires to promote the social, economic and cultural interests of the City of El Paso; and

WHEREAS, by promoting the common interest of both cities, the social, economic and general welfare of the citizens of both cities are enhanced;

NOW, THEREFORE, BE IT AGREED AND KNOWN that the City of El Paso, Texas, and the City of Zacatecas, México, commit to the bilateral promotion of their respective cities as evidenced by the signatures affixed below and shall be known from this time forward as "Sister Cities."
